

## Why IRS driving cost is 52¢/mile & the national average is 22¢

The IRS uses AAA data and the AAA calculates the cost of auto ownership based on their members typical cars: "designed to model the average AAA member's use of a vehicle for personal transportation over five years and 75,000 miles of ownership. (bold added)

The AAA's cost differs from actual 2005 USA average cost mainly because AAA members drive newer, more expensive, cars than the average American, so **AAA used an average car age of 2 ½ years while the average American car is 9 years old.**

AAA reports cost per **vehicle-mile**, while comparisons with transit require costs per **passenger-mile**.

(USA average data was not found for several items, so either the AAA data was used or estimates were used for the "USA Average 2005" column. This data is enclosed in brackets: [data].)

AAA based its <b>insurance costs</b> on a full-coverage policy for a married 47-year-old male with a good driving record, living in a small city and commuting three to 10 miles daily to work.
